Recreation Committee

There are many challenges we have to deal with at this point in our history:

Deferred capital investment, changing realties of retail, tax levels made more burdensome by Federal Tax Reform Act and increasing cost of items like health insurance and pension benefits which are controlled by outside forces, among others.

In the past two years we have accomplished a lot: We have completed several infrastructure projects which had been on the table for decades; worked very closely with landlords, brokers, planners and business owners to create multi-pronged approach to improving the downtown; began a comprehensive parking study which will help us improve the current situation; identified some additional sources of non-tax revenue such as local filming fees; upgraded many of the internal computer systems to improve productivity; began building up our recreation program; and hired a planning consultant to improve the efficiency of the building department and the Planning Board, just to name a few. There is plenty of on-going work that will need to be continued, as well as some new projects and issues on the horizon.

I look forward to finding workable, forward-looking solutions to the existing and new challenges which the Village will face in the next two years. Thank you for giving me the opportunity to do so.

Lt. Olsen gave the Police Chief's report in the absence of Chief Poleway.

Police Chief's Report

- 1. As you are aware, there is a medication disposalbox located in the lobby of Village Hall to safely discard of unused or expired medications. I just wanted to remind everyone that there are certain items that are not supposed to be left in the drop-box and they include: Hydrogen peroxide, thermometers, inhalers, needles, medications from businesses or clinics, aerosol cans, and ointments, lotions, or liquids. There have been incidents in other jurisdictions in which police officers were emptying the contents of their drop-box and came in contact with substances that have caused reactions that required medical attention. This shows what can happen when prohibited items are placed inside the medication disposal box. There is a listing of accepted and prohibited items right on the drop-box if you are unsure if an item can be deposited or not.
- 2. April is Distracted Driving Awareness Month and Police officers throughout New York State will be looking for cell phone law violators. New York prohibits all drivers from using portable electronic devices. Distracted driving is any activity that diverts a person's attention away from the primary task of driving. All distractions endanger driver, passenger, and bystander safety. Duringthe month of April, we encourage everyone to drive with focus and to reach their destination safely.

According to the National Highway Traffic Safety Administration, 3,154 people were killed and 424,000 were injured nationwide in crashes involving a distracted driver in 2015. In 2016, there were 3,450 deaths and 426,000 injuries. That's a 6% increase over 2015 statistics and 14% over 2014.

Text messaging and driving is especially dangerous as it requires visual, manual, and cognitive attention from the driver, and it is by far one of the most alarming distractions. It takes about five seconds, on average, to read or send a text. Not a lot of time. But, in that span of time, with your eyes on your phone and not on the road, a vehicle travelling 55 miles per hour cantravel the length of a football field. In that instant, over that distance, a life can be taken-maybe even yours.

What can you do? Turn off your phone. Designate a sober driver. Reduce your speed. Crying children can wait until you can pull over safely. Wear your seat belt. These are all simple steps that potentially create a lifesaving change that will make you safer year-round. Recommit yourself to safe driving by not giving in to distractions and by focusing solely on the road. You'll save yourself the cost of a ticket and maybe even save a life.

Village Code section 273-35.1is a "no-idling law" which prohibits vehicles from idling for more than three minutes, if parked or standing, when the ambient temperature is in excess of 40 degrees Fahrenheit. The area's most often affected by idling vehicles and the fumes they produce are the schools and the train station. Please remember to turn your vehicle off if you are going to be stopped for more than three minutes to minimize the negative impact created by idling cars and the carbon monoxide they emit.
- 4. See something-Say something I would like to remind everyone to stay vigilant in reporting any suspicious activity that may be observed.
