WHEREAS, the membership of AFSCME ratified the terms and conditions contained in the Memorandum of Agreement on March 12, 2020; and WHEREAS, the Memorandum of Agreement between the Village and AFSCME regarding the terms and conditions of employment for the period June 1, 2019 through and including May 31, 2023 is being presented for approval by the Village of Larchmont Board of Trustees; now therefore be it

RESOLVED, that the Memorandum of Agreement between the Village and AFSCME dated August 3, 2016 regarding the terms and conditions of employment for the period June 1, 2016 through and including May 31, 2019 is hereby approved; and be it further

RESOLVED, that the Village Administrator is hereby authorized to execute a Collective Bargaining Agreement for the period June 1, 2019 through and including May 31, 2023 between the Village and AFSCME incorporating the terms and conditions of said Memorandum of Agreement.
