WHEREAS, pursuant to federal law, Public, Educational, and Governmental (PEG)

Access Channel funds received by the Village through cable franchise agreements must be restricted in use for capital projects related to the

operation of cable television programming; and

WHEREAS, in FY 2022-23, the Village received \$266,801 in PEG funds, which must

be allocated to the Restricted Fund Balance in accordance with the

above-mentioned law; now therefore, be it

RESOLVED, that the Board of Trustees hereby authorizes the creation of a new PEG

Restricted Fund Balance Account within the General Fund, and further authorizes the restriction of PEG funds received in FY 2022-2023 in the amount of \$266,801 from the FY 2022-23 General Fund Miscellaneous Revenue Account A1-0000-2770-000-00 to the newly created General

Fund PEG Restricted Fund Balance.

On motion of Trustee Fanelli, seconded by Post, and unanimously carried the following resolution was adopted:

WHEREAS, pursuant to the provisions of Section 5-520 of the New York State Village

Law, the Board of Trustees, by resolution, may transfer funds from

existing and unexpended balances; and

WHEREAS, sufficient funds exist in the undesignated fund balance pursuant to our

fund balance policy and the Village Board is desirous of allocating some

resources to additional projects; now, therefore, be it

RESOLVED, that the Board of Trustees hereby authorizes a supplemental

appropriation of \$10,000 from the General Fund Unassigned Fund Balance to the Village Hall Building & Grounds Repairs/Maintenance

Account A1-1620-4012-000-00; and be it further

RESOLVED,

that the Board of Trustees hereby authorizes the transfer of \$81,000 in unallocated expenses from General Fund Assigned Fund Balance to the Capital Projects Fund based on the following budgetary authorizations:
